Many energy suppliers require you to give 30 days' notice to leave BEFORE your contract ends; they could catch you unaware with avoidable expensive prices if you fail to renew!

Don't get caught out...

60-70% of small businesses failed to act last year and many could have saved over 40% on their Electricity & Gas bills.

If you move onto a Variable Price Plan or Out of Contract rates...

- Your prices will increase substantially above market prices – usually by 40% plus above current lowest prices!
- If you fail to renew you may be trapped for at least 30 days on expensive variable rates.
- If you serve notice of termination but then fail to move this will even more expensive.

What happens next...

On receipt of a completed request, USC will contact your supply company on your behalf to find out if you are in a contract and report back to you. If you are in contract, USC will note your contract end date and contact you again four months before your renewal date offering you very competitive rates AND will stop you from moving on to unnecessary expensive energy prices.
